AWARDS GUIDELINE

Season Awards

This guideline provides an understanding to persons of the Buckley Park Cricket Club, on the awards provided at the completion of season, and the qualifications to be eligible for these awards.

Qualification

For individual awards presented the recipient must:

- be financial, where applicable
- play in at least half of the games in that particular grade

Exceptions

The Committee of Management (CoM) may:

- use its discretion for any award winners that don't meet these criteria
- rule a player ineligible to receive an award for disciplinary reasons
- add awards at its discretion

On-Field Awards

Club Champion, Horse Barmby Shield, and team MVP's, including the Ray Finn award.

These are statistical awards presented to the player with the most points at the end of the season with points assigned as follows:

- 1 run = 1 point value to the batter
- 1 assisted wicket (caught, hit wkt) = 15 points value to the bowler
- 1 unassisted wicket (bowled or lbw) = 20 points value to the bowler
- 1 unassisted run out = 10 points value to the fielder
- 1 catch or stumping = 5 points value the fielder
- 1 assisted run out = 5 points value to both fielders

Batting Awards

Batting averages awards are presented in all grades to the player with the highest overall batting average. Minimum qualification is 300 runs.

Batters who make a century are presented with an award.

Bowling awards, including the Graham Muir First XI Bowling award

Bowling averages awards are presented in all grades to the player with the lowest overall bowling average. Minimum qualification is 20 wickets.

Bowlers who take 5 wickets in an innings are presented with an award

Bowlers who take a hat trick are presented with an award

Paul Mills Award

The Paul Mills award is presented to the 'best' Under 21 player of the season. As well as the 'best' under 21 player, the recipient must play the game and conduct themselves in a manner that respects the following values; Discipline, Strength, Courage, Loyalty, Honour, Character, Family, Friends, and Freedom. The Junior coordinator will discuss potential recipients with the Chairman of Selectors, whom will then make a recommendation to the CoM for final consideration.

Ian Hunter Fielding Award

The Ian Hunter award is to be presented to the player that is adjudged to be the best fielder in the club, regardless of grade, for the season. The Club Coach and Chairman of Selectors will make a recommendation to the CoM for final consideration.

Team of the Year

At the completion of each year the Club Coach and Chairman of Selectors selects a balanced 'Club Team of the Year' based on performances over the home and away season (5 batters, 1 all-rounder, 1 wicket keeper and 4 bowlers). Players from any grade can be considered for selection.

Premiership Awards

The premiership winning captain will receive an award from the club recognizing their efforts through the season. In the past this has been a framed premiership team photo.

Premiership winning players will receive an award from the club.

Player of the Finals

The CoM has the discretion to award this for each grade. Generally, the side will play in a minimum of 2 finals for this award to be considered.

Barrie Clissold Best Club Person Award

The Barrie Clissold, Best Club Person award is voted on by all members of the CoM. It is awarded to the person that the CoM believes has 'gone above and beyond' for the club throughout the past season.

Life Membership

- The Club has the power to grant Life Membership to any person who has made special contributions to the Club
- Such contributions must have been made for a period of at least seven (7) years
- Nominations for Life Membership can be made, reviewed, and approved by the current CoM
- Nominations may only be made by a current member of the Club
- Not more than two (2) persons may be granted Life Membership in any one year
- Life Members are entitled to all the privileges of the Club Membership at no cost

Team of the Decade

At the end of each decade, commencing in 2002, a panel will be appointed by the CoM to select a "Team of the Decade". Qualification for selection in this team will be restricted to players who have played at least 50 games in the club's 1st and/or 2nd XI during the decade. The team will comprise of the following:

- 5 Batter
- 4 Bowlers
- 1 All Rounder
- 1 Wicket Keeper
- 1 Twelfth Person
- A Captain shall be named.

Each player selected in this team shall receive a Certificate to honour their selection. The Club shall provide a plaque to be held within the clubrooms to commemorate this team.

Hall of Fame

At the clubs AGM following the 2013/14 season a sub-committee comprising of Lachlan Hunter, Paul McDonald & Anthony Haseloff was formed to:

1. Assess the merits of forming a Hall of Fame for Buckley Park Cricket Club.
2. Provide appropriate criteria and measures in relation to qualification.

The sub-committee came to the conclusion that the adoption and inception of a BPCC Hall of Fame would be recommended to the members at the upcoming AGM. The recommended qualification for induction into the Hall of Fame is listed in more detail below.

The main premise of the Hall of Fame is to recognise players and/or officials who have made significant contributions to the club over an extended period highlighting on field cricket excellence.

Qualification for Hall of Fame consideration is:

- Player to achieve 250 total points as a minimum requirement
- This point value is discretionary in the event of posthumous award or exceptional circumstances
- To be treated as a recognition of outstanding on field achievements

Selection Criteria:

- Meet the minimum qualification requirements
- Be of good character within the club
- Recommendation by Hall of Fame Sub Committee that is endorsed by current Club Committee
- Maximum of 2 inductees in any one year.

Criteria 1 – Games Played

- 100 games = 5 points
- 150 games = 10 points
- 200 games = 15 points
- 250 games = 30 points
- 300 games = 45 points
- 350 games = 60 points
- 400 games = 75 points
- 450+ games = 90 points

Criteria 2 – Accolades

- Club individual award = 10 points
- Club multiple awards = 20 points
- Competition individual award = 15 points
- Competition multiple awards = 30 points
- BPCC Club Champion = 25 points per selection
- BPCC MVP (other than top grade) = 10 points per selection
- BPCC Team of the decade = 20 points per selection

Criteria 3 - Premierships

- Premiership in the club's First XI 2 day team (as per current standings) = 25 points per premiership
- Premiership in any other grade, including T20 and First XI One Day premierships = 10 points per premiership

Criteria 4 -Statistics

- Batting Aggregate
 - 3000 runs = 10 points (15 current players)
 - 4000 runs = 20 points
 - 5000 runs = 30 points
 - 6000 runs = 40 points
 - 7000+ runs = 50 points
- Batting average (min 75 games & 2000 runs)
 - 25 – 30 = 10 points (14 current players)
 - 30 – 35 = 20 points
 - 35 – 40 = 30 points
 - 40+ = 40 points
- Bowling aggregate
 - 150 – 200 wkts = 10 points (16 current players)
 - 201 – 250 wkts = 20 points
 - 251 - 300 wkts = 30 points
 - 301 – 350 wkts = 40 points
 - 351+ wkts = 50 points

- Bowling Averages (min 75 games & 125 wkts)
 - 22 – 25 = 10 points
 - 19 – 21.9 = 20 points
 - 16 – 18.9 = 30 points
 - Under 16 = 40 points
- Fielding (dismissals)
 - 100 – 150 = 20 points
 - 151 – 200 = 40 points
 - 201+ = 60 points

Criteria 5 - Level of Cricket Achieved

- Luscombe Shield/Association 1st Grade = 10 points
- VTCA Senior/Sub District 1st = 20 points
- District 1sts = 50 points
- State Level = 100 points
- National Level = 150 points

Criteria 6 - Honorary

- Captain of First XI = 20 points per year
- Club Coach = 20 points per year

Power to Amend

This policy can be amended at any time by the CoM, if the CoM, is of the opinion that such an amendment is necessary, including, but not limited to the discovery of a drafting error or oversight, or for any other reason determined to be in the best interests of Buckley Park Cricket Club.
